

## **September 15, 2006**

The Mahaska County Board of Supervisors met in special session on the above date at 9:00 in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Chairman – Greg Gordy; Member – Henry W. VanWeelden. Also present was Kay Swanson, Mahaska County Auditor. Absent was Vice chairman – Lawrence Rouw.

Chairman Gordy called the meeting to order with a moment of silence.

It was moved by VanWeelden seconded by Gordy to approve the agenda for today's meeting. All present voted aye. Motion carried.

Kay Swanson, Mahaska County Commissioner of Elections reported that the total number eligible to vote on September 12, 2006 as 13,685. There were 310 who voted. There were 24 absentee ballots requested for the School Board Election for 2006. 21 ballots were returned in time to be counted. 3 ballots were not returned.

In Fremont Community School District there were 744 eligible voters and there were 124 votes cast at the polls and 7 absentee ballots being cast.

In North Mahaska Community School District Director #1 there were 492 eligible voters and there were 5 votes cast at the polls and 0 absentee ballots being cast. The only candidate on the ballot was Indian Hills Community College Director #1.

In North Mahaska Community School District Director #2 there were 435 eligible voters and there were 3 votes cast at the polls and 0 absentee ballots being cast. The only candidate on the ballot was Indian Hills Community College Director #1.

In North Mahaska Community School District Director #3 there were 279 eligible voters and there were 2 votes cast at the polls and 0 absentee ballots being cast. The only candidate on the ballot was Indian Hills Community College Director #1.

In North Mahaska Community School District Director #4 there were 396 eligible voters and there were 7 votes cast at the polls and 0 absentee ballots being cast. The only candidate on the ballot was Indian Hills Community College Director #1.

In North Mahaska Community School District Director #5 there were 419 eligible voters and there were 13 votes cast at the polls and 1 absentee ballot being cast. A candidate for North Mahaska Community School District Director #5 and Indian Hills Community College Director #1.

In Oskaloosa Community School District Director District #1 there were 1596 eligible voters and 12 votes cast at the polls and 0 absentee ballots being cast.

In Oskaloosa Community School District Director District #2 there were 1945 eligible voters and 34 votes cast at the polls and 12 absentee ballots being cast.

In Oskaloosa Community School District Director District #3 there were 1984 eligible voters and 31 votes cast at the polls and 0 absentee ballots being cast.

In Oskaloosa Community School District Director District #4 there were 1579 eligible voters and 13 votes cast at the polls and 0 absentee ballots being cast.

In Oskaloosa Community School District Director District #5 there were 1919 eligible voters and 21 votes cast at the polls and 13 absentee ballots being cast.

In Oskaloosa Community School District Director District #6 there were 1897 eligible voters and 18 votes cast at the polls and 0 absentee ballots being cast.

After reading the votes cast for each Director District for Fremont Community School District; North Mahaska Community School District; Oskaloosa Community School District and Indian Hills Community College it was moved by VanWeelden seconded by Gordy to declare that the following candidates were elected to be school board members and the question for Fremont Community School District be approved. All present voted aye. Motion carried.
